IX. Approval of 2025 Fiber Connectivity Bids and Project Summary Presented by Tom Staten, MAISD Director of Technology Services.

Tom Staten described the scope of this project with a \$7.5 million investment in fiber connection for MAISD and the local school districts served by MAISD, including the potential of public libraries in the county, using grants and matching funds resulting in no out of pockets costs for MAISD. This project would replace existing 30 year old fiber and provide substantial upgrades in bandwidth and efficiency.

Adel DiOrio, Associate Superintendent of Instruction

- MAISD has joined the Future of Learning Conference along with several other ISDs in the state.
- MAISD and our local districts have been participants in the Igniting Passionate Leaders learning series along with Clinton County RESA and their local districts.
- The Instructional Services team has been coordinating Disciplinary Literacy learning labs for school leaders in our region to participate.
- The Michigan Career Development Model has been released by the state and the MAISD is working with local leaders to review and align the standards.

Shannon Tripp, Associate Superintendent of CTE and Early College

- Enrollment for the 2025-2026 school year at Montcalm Area Career Center is outstanding with some programs already filled.
- Students in Construction Trades and Business will be going to competitions for their programs.
- MACC has the first students from the Diesel and Heavy Equipment program to complete all certifications for a Master Mechanic. There are only 10 diesel programs in the state which makes this an outstanding achievement for this student.
- MACC held their annual Community Open House earlier this week and it saw the largest attendance of any previous years.
- Recruitment for the Early College program is in progress.
- The Early College program has been approved again this year for the Shared Educational Entity which allows state assessment scores to be recorded with the student's home district.
- Shannon Tripp will begin attending the Leadership Team meetings at MCC representing the Early College program.

Tricia Root, Associate Superintendent of Finance and Human Resources

- MAISD contracts will be adjusted to reflect the requirements in the new legislation for the Earned Sick Time Act.
- The board commended Tricia for her work in supporting business services for the local districts.
