#### **COURSE DESCRIPTION**

This course is for students interested in the criminal justice system and includes a broad overview of the history and scope of the American criminal justice system primarily through a descriptive survey of the agencies and processes involved in the administration of criminal justice. The course emphasizes historical, constitutional (legal) and political considerations. This introduction to criminal investigation gives students a logical framework for understanding the investigative process. Major sections cover current issues such as environmental crime, the looting of archaeological sites, videotaping of crime scenes, street gangs, and drugs. Case studies throughout the text emphasize the applied technique of criminal investigation. Graphs, charts, and compelling photographs found throughout the text depict the practical aspects of investigation and help to clarify difficult scientific concepts.

# **ACADEMIC CREDITS**

Students who take Public Safety can earn credits for the fourth required math credit, a third credit of science, a visual performing and applied arts credit and/or may substitute this CTE class in place of a second year of foreign language. Local district policy and other circumstances may limit or expand the use of CTE classes in place of other credit requirements.

#### POSTSECONDARY CONNECTIONS

The MACC offers students with a B or better each semester the opportunity to earn articulated credits at several community colleges and universities around the state. Public Safety offers articulated credits at Montcalm Community College. Additional information can be found on our website or by talking with the instructor.

#### WORK-BASED LEARNING OPPORTUNITIES

The second year program of Public Safety offers work-based learning in the form of internships with area law enforcement based agencies.

# ASSIGNMENTS

There will be chapter assignments, as well as projects, a midterm and final exam each semester.

#### **CRITERIA FOR CONSIDERATION TO 2ND SEMESTER, 2ND YEAR, & INTERNSHIP PROGRAM**

Acceptance into second semester of Public Safety is contingent upon achieving a passing grade (D- or above) in first semester.

Acceptance into the second year program is contingent on completion of the first year with a C or better in class, and judgement of the instructor. Sufficient grades do not guarantee 2nd year acceptance. Students who achieve a C or better, but who are disruptive in class, turn in work late, or do not take the program seriously, may not be asked to return for a second year.

Those accepted as 2nd year students who achieve a B or better their first year, may apply to the internship/work based learning program. Because of the level of independent study involved (3 days a week out of the MACC classroom,) acceptance is strictly limited and highly dependant on interviews by local law enforcement officials and judgment of the instructor that the student is able to maintain a level of professionalism needed to represent the class in the community. Students also must have their own transportation to job sites.
