- 1. Please keep the device away from liquids and food. If the device should become soiled, wipe it off with a damp cloth and contact support@maisd.com as soon as possible.
- 2. Please report any damage to the device to your child's teacher as soon as possible.
- 3. If the device is in a case that is designed to be on while in use PLEASE keep the device in its case at ALL times. If the device is damaged, lost, stolen, or not maintained properly it could mean an interruption in its availability for future use. The student/parent will be responsible for repair or replacement costs for intentional damages. Contact support@maisd.com and the child's teacher as soon as possible if there is damage.
- 4. If the device is a chromebook, PLEASE Do Not Carry it by its screen. Make sure to carry it with two hands located at each side of the device.

- 5. Please Do Not slam the chromebook closed as it could break the screen.
- 6. If the device is an iPad PLEASE make sure to not use a hard object on the screen.
- 7. Please Do Not attempt to fix or repair the device yourself. Please contact your child's teacher and support@maisd.com if there is damage to the device.
- 8. For those without access to e-mail: Phone: 616-225-5777 (The call will ring into a queue of available technology support staff. If staff are not available, leaving a voicemail message will create a technology ticket and attach the voicemail message to the ticket. If you don't leave a message, no ticket or response will be received.
